Thank you for choosing to study at Cardiff Metropolitan University. You will appreciate that all public services charged with responsibility for the welfare of children and young or vulnerable people, need to be particularly careful about the character and background of its personnel whose work will bring them into contact with children and young or vulnerable people. If the placement you undertake as part of your programme brings you into contact with children and young or vulnerable people, as part of the admissions process of your programme you must complete our self declaration form found overleaf to inform us of criminal convictions, bind-over orders, cautions or warnings.

We ask you to reveal any criminal convictions, bind-over orders, cautions or warnings that are not "protected" as defined by the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 (as amended in 2013). The University reserves the right to take into account all information contained in this form in determining the suitability of an applicant and where something is disclosed that has not been considered by the University previously, it may be taken into account when determining whether to allow a student to start or continue with a programme of study. You should note that satisfactory completion and return of this form is a condition of entry to your course. If a conviction is indicated, please provide in a sealed envelope a letter detailing/explaining the content and circumstances of the conviction/caution in order to assist with the processing of your application.

This procedure is a necessary condition that needs to be fulfilled as a duty of care to university staff, students and visitors, and in order to safeguard the protection of children and young or vulnerable people. **Please note this form will need to be completed prior to you commencing the programme. It is essential for your placement and failure to comply with this may jeopardise your place on the programme.**
